University of Texas at San Antonio is a Hispanic-Serving, urban-serving, research intensive (R1) institution with roughly 35,000 students offering more than 159 degrees across six academic colleges.

*COLLEGE FOR HEALTH, COMMUNITY AND POLICY, DEAN (2020-CURRENT)*

The College for Health, Community and Policy is the largest college at UTSA with nearly 7,000 students at its inception in 2020. There are eight departments, one program, and five research centers and institutes. There are 188 faculty and 68 staff in the College. The College's departments are Criminology and Criminal Justice, Kinesiology, Psychology, Public Administration, Public Health, Social Work, and Sociology and Demography. There is a Nutrition and Dietetics program that reports to the College as well. The centers and institutes are the Center for Community-Based Applied Health Research, the Institute for Demographic, Social and Economic Research, the Institute for Health Disparities, and the Center for Applied Community and Policy Research.

Duties: Lead all strategic planning, undergraduate and graduate program development, collegiate administrative structure and governance, budget (\$42M state appropriation and \$10M funded research program) and facilities across two campuses, enrollment and student retention, research and outreach programs, professional development, and personnel management.

Accomplishments:

- Spearheaded the launch of the new College, including developing a Business Service Center model of financial management, a College magazine, relevant websites, as well as a website overhaul
- Facilitated a college-wide strategic planning process, including by-laws, faculty review guidelines, a community engagement plan, and a DEI-related strategic plan
- Increased alumni contact and donations significantly, formed a Dean's Advisory Council
- Increased inter-department and community engagement via Dean's Community Lecture Series, Media Club, Research Roundtables, and end of year celebrations, as well as hiring an Associate Dean for Community Engagement and Partnerships
- Facilitated all faculty recruitment (~10/year) and recruited four external Department Chairs, five Associate Deans, six post-doctoral fellows and many strategic hires
- Facilitated the separation of the Kinesiology, Health and Nutrition department into three separate units as well as the combination of the Departments of Demography and Sociology into a single unit

- Increased alumni contact and donations significantly (three planned gifts totaling \$2.2M and three cash gifts totaling \$50,000) via a newly formed Visiting Committee
- Increased intra-department engagement via lecture series and an annual award banquet to celebrate department successes
- Recruited for six expansion positions (five faculty) in first two years as Chair, no tenure stream departures during my tenure, nearly half of faculty promoted in last five years, two opportunity hires
- Facilitated the separation of the Sociology and Anthropology singular major to two distinct majors, implementing changes to writing, capstone and general education requirements in tandem
- Supported and built new online criminology minor to buttress entrepreneurial resources in the department, initial enrollment in 2018-2019 was 85 minors
