GENERAL DESCRIPTION:

Responsible for the accuracy of administrative assignments within the department, including typing of correspondence, input of spreadsheets and scheduling of appointments.

Marketing and Development Internship

This internship program will focus on the practical application of marketing and fundraising principles to generate revenue for the affiliate. Possible assignments in this role include:
